- **ii.** Minutes from Last Meeting
 - a. Motion to accept minutes from last meeting: Molly Crow seconded: Felicity Beckman
- **iii.** President's Report
 - a. Booster is key for FHS. Sports teams receive minimal amount of funding from the district, and as such, rely very heavily on FMBC to help support the coaches and athletes
 - **b.** At this time, we'd like to address the Elephant in the Room and talk directly to you about the active theft case.
 - c. The FMBC Executive Board is making their way to the Coach's Meeting and to each team's parent meeting to openly discuss the improvements made to ensure this doesn't happen again.
 - d. Here are some of the improvements made to date:
 - i. First and foremost, we switched banks to Texan Bank to allow for more security
 - ii. Secondly, and most importantly, we have partnered with VARC Solutions, a Friendswood-based bookkeeping firm, to reconcile our monthly and annual books. VARC Solutions works, pro bono, with the FISD Education Foundation to manage its day-to-day accounting operations. For us, they have graciously agreed to reconcile our monthly and annual books, pro bono. With each month's financial packet, they include a letter stating the books are reconciled against the Bank Statement from Texan Bank.
 - iii. In addition to monthly/annual reconciliation, VARC Solutions is also helping prepare accounting procedural manuals so future executive members can be oriented to the process more thoroughly.
 - iv. We have set up a Mustang Unite Fund that raised \$16,473.72 that has already been distributed to teams proportionate to the amount of funding lost due to the theft
 - v. We have streamlined and pushed out more broadly our FMBC Membership Drive. We have raised \$24,676 to date, that will be distributed to teams evenly at various points in the year.
 - vi. We have been approved to look at a booster-wide fundraiser to help alleviate pressure on teams to raise their own funds
 - vii. We will be working with each rep and coach to develop an annual team budget and annual operations plan. The budget will help teams understand how much money will need to be raised each year; while the operations plan will help streamline community work across all teams, as well as serve as a key document in transitioning to a new rep in future years
 - viii. We have been revising the By-Laws for the first time since 2003 and will be updating them to reflect current non-profit trends
 - ix. We are reconfiguring cash management:

- 1. We are now accepting online payments for player invoices that go directly to our account at Texan Bank and booked to a specific sport.
- 2. We are working with VARC Solutions to identify better controls for concessions, and looking at a credit card option for concessions
- x. We are creating a new rep orientation that will help new reps understand their role and the standard processes that will be put in place for all teams
- xi. We are working to require teams to subsidize some player dues and costs more readily and will ensure limited carryover funds
- e. Gave an update on the case. Please understand, we are limited in what we can say because this is an active investigation.
 - i. We cooperated fully with law enforcement and the ADA.
 - ii. Receipts and bank records were combed through thoroughly, and evidence was provided to law enforcement.
 - iii. While the Booster account hadn't been properly reconciled since 2017, it is currently up to date and matches bank statements
 - iv. In May, Shonna "Nikki" Guerra was indicted with 1st degree felony count of theft.
 - v. She was arrested and taken to Galveston County Jail. She did post bail.
 - vi. She has a meeting with the judge at the end of August to determine if her attorney will push for or be open to a plea, or if they will go to trial.
 - vii. Our goal is to see jail time and will continue to support the efforts of the investigation as much as possible




