v. Treasurer's Report

a.Bank balance as of today is \$327,949.12. Our financials have been reconciled through September 2022 and approved by VARC. We are still working with the District Finance department to complete the revised Financial Training. We will likely run through the presentation at the November meeting. Please keep in mind that FMBC does not reimburse Sales Tax. We have a copy of our Sales Tax Exemption form on our website under Booster Documents, along with notes for several retailers on how to obtain tax-exempt purchases. Some online retailers will reimburse your paid sales tax after the fact if you contact them and provide a copy of the sales tax exemption form. Please make sure parents know about sales tax.

ix. 2nd Vice Presidents – Reports

- 1. Baseball-Baseball agrees with our account reconciliation from Jackie. 2. Baseball has a few fan items for sale on our website. We will be kicking off our stadium banner/sign sponsorship drive next week. Our intent is to raise money to cover a home dugout renovation, field maintenance, batting cage fans, and new uniforms for the 2023 baseball season which starts in February. 3. Baseball participated in the homecoming parade but our floats were the very least cool of all the sports represented.
- 2. Basketball Boys –After some really good competition in our JV and Varsity Fall League, the boys are gearing up for preseason play starting Nov. 5. Tryouts will be held Oct. 27-29th. After our players are chosen, we will have our annual program potluck dinner on Nov. 2. Our fan shirts and gear will be offered starting Nov. 2nd, also. We are excited to get our season underway!
- 3. Basketball Girls Our girls earned a spot to be featured in Vype magazine, basketball edition. Claire Radtke, Helen Byrd and Victoria Elizondo attended a photo shoot on Tuesday at U of H. Team fundraisers coming up are team driven online fundraiser on Oct 21 and Sonic carhop on Dec 17. Girls basketball will also offer the buddy program and theme nights as a way to get more fans to the games. Tryouts are this week and season starts with a scrimmage on Oct 29. PNL reconciled
- 4. Cross Country (B&G) & Track and Field (Boys)- Cross Country successfully took home both Varsity District Titles this past week! The Varsity Teams will now advance to the Region Meet on the 25th in Huntsville where they will battle it out for entry to the State Meet. The JV boys dominated their race, taking the first 6 places, obtaining a perfect score of 15. The JV girls and Freshmen boys put forth an outstanding effort and were runner ups in their divisions as teams. All in all, these are incredible results- two Varsity District Championships, a third title from JV, 2 runner ups, and 4 individual District Champions from 5 races. The CC booster was able to use some of the money from our fundraiser to purchase Cross Country 3 sets of their own Normatec boots with carrying cases to take on the road with us. This helps make sure our athletes have fresh legs to run on!
- 5. Track/Field Girls We are halfway through our off season training and the girls are looking great! Our first track meet of the season will be February 3rd! It'll be here before we know it! We have some new gear coming for our cold months of the season, and the girls are excited about that. Long sleeve meet tops! YAY! - 6. Cheerleaders Our financials are approved. Over the last month we hosted the Varsity Football Dinner, celebrated our 15 Seniors at Senior Night and worked 3 concession stands. In preparation for two competitions in November we incurred registration fees and the purchase of signs and flags totaling \$6,589.04 and the monthly training expense of \$5,680.00. Minor expenses included building our Homecoming float and preparing

- 7. Football –Football is in full swing with just a few short weeks left of our regular season. We are enjoying our new tunnel and it has been a hit at both senior nights as well. Each week our players enjoy a team dinner together and two weeks ago it was hosted by our cheerleaders. The boys love to have this time together but for some reason they love it even more when the cheerleaders host. Huge thank you to cheer. We are using player fees and feeding the players each week before the game and sometimes after. Homecoming was such a great time for the boys. After the parade, they had their traditional team dinner at Perry's. The players love this bonding time and appreciate the great food. We have 2 more games left and are hoping to get wins from both of them. Our coaches pick Horse Power Athletes for each home game. These athletes are given a Horse Power Athlete t-shirt and are invited to run through the tunnel with our players. The past players that have been chosen are below.

- 12.Soccer Girls PNL is approved. Signed for concession stand Nov 4th Varsity Football game. Coaches are in the process of forming teams for the upcoming season. Fan cloth and Mustang card fundraiser will start after Thanksgiving break.
- 13.Softball The girls are continuing with fall ball on Monday nights, through the beginning of November. We are also in the middle of our banner sponsorship drive. Our booster funds recently went to putting concrete and turf in one of our bullpens, field maintenance, and large fans for the batting cages (which is an expense we are sharing with baseball). - 14.Swimming/Diving/Water Polo –Water Polo Last week, both Water Polo teams competed in the bi-district playoffs. The girls are District and Area Champs after winning their match over Clear Lake, Deer Park and Clear Springs. They advance to the Regional tournament on Oct 22. The boys lost their opening round playoff game, a thriller in double overtime to Clear Springs 14-12. It was a great opening season for both teams in the first year as a UIL sport. Swim We have started practices. Our first meet will be the Surfside Invite on Oct 29th in Angleton. Booster Activities in October –Purchased flowers for our Water Polo senior night. 
