- iii. **President's Report –**
 - a. Hello all! Welcome to the 2025-2026 booster and school year! I hope everyone had an amazing summer and I can't wait to jump right into this year. First and foremost, THANK YOU for being here and volunteering your time to FMBC, our athletes, coaches and sports. We could not do it without you! We have overcome many obstacles in the last five years, and I believe we have not only overcome those obstacles but grown leaps and bounds as an organization. One of our prime focuses is aiding our sports and reps in raising money for their sports to be able to run their seasons and this year we are incorporating a marketing board position to grow exponentially across the board. A few years ago, we had a shift in booster, from focusing on growing general boosters fundraising to focusing on each sport growing their fundraising. I believe we have successfully achieved that goal! As reps you have worked so hard, and I know your coaches, athletes and parents appreciate you and all you do! We are ready to start working to incorporate the athletics department into our fundraising efforts for general booster! I can't wait to see where this year takes us and to see all we can accomplish this year.
 - b. **General Booster-**
 - i. The General Booster serves as the umbrella booster organization. The board is made up of five members, and the sport representatives serve as the 2nd Vice Presidents. The role of the General Booster is to support athletics and representatives by serving as a resource and communication link. We do not fundraise as a booster club to distribute funds directly to sports; instead, we assist the 2nd VP representatives in raising funds for their specific sports. Each representative should work with their coach to create an operations calendar that outlines fundraising and budgeting needs, and they are expected to keep accurate records of all expenses.
 - c. **Sports rep training:**
 - i. During sports rep training, all information should be reviewed for accuracy and reported to the secretary if updates are needed. Each month, a Profit & Loss (P&L) statement will be distributed, and coaches will now be copied on those emails to ensure full transparency. If a coach reaches out with questions or concerns, representatives are expected to respond in a timely manner. Representatives should also continue working with their coaches on operations calendars to ensure budgets and carryovers are aligned.
 - d. **Finance-**

- i. all reimbursement requests must include receipts and as much detail as possible.
- e. Marketing-
 - i. the goal is to communicate broadly in order to help sports raise as much money as needed.
- f. All sports concessions will now operate as cashless, card-based systems. The booster will provide iPads for transactions, and those funds will deposit directly into the sport's account. If a sport chooses to use its own Venmo, the representative must provide documentation showing how much was collected and how much is being requested in a reimbursement check
- g. BTS meeting with coaches we provided lunch for all coaches

i. 1st Vice President's Report

- a. Introduction
 - i. My name is Chris Partida and I am the new VP. My family and I moved to Friendswood in 2020. My wife (Larissa) and I have 2 girls, Cadence 16yr (Junior) and Rowan 9yr (4th grade). Both are involved in sports, Cadence plays Softball for the high school and Rowan plays Basketball in the local Be Someone league. I am excited to be a part of FMBC and help the athletes, coaches, and fellow booster members any way I can. Looking forward to an awesome year!
- b. General Booster Sponsorship Update
 - i. We have raised \$35,100 to date. Exceeding our goal of \$30,000 for the 2025-2026 General Booster Sponsorship Drive. We are still accepting sponsorships!
 - ii. We also have One Sport Passes available for most sports. They are \$150 with a Silver level sponsorship. Reminder that \$25 will go back to that individual sport.
 - iii. We will be sending out Thank You cards with the group photo taken from Meet the Mustangs. Cards are expected to come in August 20th and will be mailed out to all sponsors early next week.
- c. Student Sports Passes
 - i. We have sold 129 sports passes so far. This equates to \$5,160 in Student Sports Pass sales.
 - ii. Student Sports passes are still available. Please help spread the message!
- d. Coaches Concession Cards
 - i. Coaches list has been requested from Jennifer.
 - ii. Once coaches list is received, a link will be sent for them to fill out information for the cards.
 - iii. Coaches will be able to receive water and soft drinks at sport run concessions. Cards will not be valid in the Competition Gym.

ii. Treasurer's Report

- a. Please make sure that your July Profit & Loss (P&L) statement is reconciled before Friday and contact Tracey immediately with any issues.
- b. There was a four-day period in August where PayPal fees were not deducted; Tracey will notify you as soon as this is resolved.
- c. If you have outstanding checks, they will appear in this section of your report. If you notice any discrepancies, please email Tracey.
- d. Checks are cut on Mondays and Thursdays.

iii. Secretary Report

- a. If your sport is getting a new rep who needs to be voted in, please email Ava and me prior to the meeting.
- b. Minutes that you email should focus on **how FMBC funds are being used**, not on accolades.
- c. If your sport will not be represented at the meeting, please email Ava and me beforehand.
- d. Please try to submit your minutes by **Tuesday before the Wednesday meeting**.
- e. Only one agenda sheet will be printed for each sport binder, regardless of the number of reps your sport has.

iv. **Marketing**

- a. Concessions,
 - i. we will be handling operations differently this year in place of traditional concessions. If you have any questions, please email me as soon as possible. I am here to support and provide all necessary information. FMBC has purchased Tello Wi-Fi for two iPads to ensure connectivity. the remaining syrup will be delivered on Tuesday. FMBC will provide syrup, ice, and maintenance for the stands. We encourage all sports to utilize the stands. Storage is available, including lockable storage. Please note that this arrangement is temporary, as the district will be renegotiating with Aramark.
- b. Marketing
 - i. I will share posts from each sport on the General Booster page. I will not create or manage your sport's page, but I will share the content you have already posted since you control your own information. To coordinate this, I need the name and contact information of the manager for each sport's social media, as well as the social media handles. Please send this information to the marketing email. A Google link will also be sent out where you can enter your sport's social media handle, manager's name, and other details

v. **Jordan Johnson – Athletic Director**

- a. Daron Scott
 - i. Welcomed everyone and thanked reps for stepping into this role. This involvement is a huge benefit to athletes and their families.
- b. Expectations
 - i. Coaches are expected to maintain open communication with their reps.
 - ii. If a coach is not actively engaging, reps should reach out to FMBC for support.
- c. Banquets
 - i. Coaches must ensure administration and staff are informed of banquet dates before planning begins.
 - ii. Reps are encouraged to propose 1–2 possible dates.
 - iii. Athletics administration may want to attend, so coordination is important.

vi. **2nd Vice Presidents - Reports**

1. Baseball - We are using booster funds to buy necessary equipment for practices. PNL is reconciled.
2. Basketball – Boys - Boys Basketball recently used FMBC funds toward the purchase of two digital advertising kiosks, which will also be shared with volleyball and girls basketball. The kiosks will give the court sports an opportunity to attract community sponsors by selling digital ads which will be displayed at home games. Boys' basketball participated in Meet the Mustangs and launched our new Buddy Club at that event. We have already sold 30+ Buddy club memberships by only posting on social media. Registration closes Oct 1. We are still working through this with Tracey. There is confusion with

the volleyball and boys basketball buddy clubs since they are named the same and cost the same. We are still working through our P&L with Tracey

3. Basketball – Girls - GBB has worked over the summer to develop an extensive budget and operations calendar that will help reps stay organized and transition easily to new reps for years to come. FMBC funds have been used as follows: \$1,385 to cover part of the cost of new uniforms and \$1,741 towards the purchase of two digital advertising kiosks, which will be shared between the volleyball, boys basketball and girls basketball programs. These kiosks will enable us to attract community sponsors and supporters by selling ad space for recognition at home games. Girls' basketball enjoyed participating in the recent Meet the Mustangs event and raised \$3,820 selling raffle tickets for two baskets. GBB P&L has been reconciled.
4. Cross Country (B&G) - XC season is off to a great start! We hosted our 3rd Annual Mustang Thunder Invitational Meet on August 16th. We had 25 teams register and booster funds helped with everything from medals to race timing! P&L is reconciled; we contacted Tracey about some issues.

6. Football – Over the summer, your support has allowed us to: Provide new uniforms. Stock up on protein snacks for after workouts. Prepare for halftime fruit packages with the help of the FHS Culinary Department 🍎. Begin organizing pregame and halftime snacks for the season 🍌. A huge thank you to everyone who helped make Meet the Mustangs such a success! From athletes to parents to community members to you our amazing boosters, it was an amazing night. We did use some of our funds to make the event special — covering items like the bouncy house and the movie screen for the film on the field. If anyone would like to help us offset those costs, your support would be greatly appreciated. ❤️

This program is designed to bring athletes from *all* sports together, much like Meet the Mustangs, to support each other, cheer on fellow Mustangs, and serve our community. Plans include: Tailgates before games to boost student spirit 🍌 Supporting Spring sports by encouraging student attendance. Community service opportunities for athletes across every sport. We'd love your ideas for fundraising and to see if other sports would like to get involved. 7. Golf – Golf is gearing up for the new season, and the booster club helped us set up a link to pay fees and purchase extras online. Coaches are working on getting a finalized tournament schedule. Our P&I is reconciled through June 2025.

10. Soccer – Boys- Sport is using FMBC funds primarily for the alumni soccer game, senior night and banquet. The P&N is reconciled. We are looking into developing a media program, possibly updating/changing the website, and support of the geo video system used to film games
11. Soccer -Girls- Our season doesn't start till winter. So far, we have only been soliciting sponsors. Only funds that have been spent was purchasing new "we support the lady mustangs" signs for sponsors. Raffle tickets were sold at MTM and we will do drawing this Friday 8/22 during 7th period. Raffle basket contents were all donations. Currently getting forms and uniform pricing etc... ready for our parent Meeting in October.
12. Softball- Booster funds were recently used to purchase sponsor gifts, a new weed eater for the field, and prizes for Meet the Mustangs. We have plans to buy a microwave and mini fridge and repaint the outside of our press box. Our PNL is reconciled.
13. Swimming/Diving/Water Polo- We used booster funds for water polo pre-season dinner, banners and for meet the mustangs. The other purchases were for suits and shirts but paid for by the parents.

14. Tennis- FHS Tennis is already in full swing with fall season matches starting. We just completed another successful fundraising event - our 48-hour marathon held Aug 8-10. We raised approximately \$20,000 to help supplement additional booster funds. The funds help with additional cost for team expenses of travel, uniforms and other court expenses. FMBC is impacting our sport by providing structure, support and representation for our athletes. We had great participation and enjoyed being part of Meet the Mustangs this year!

16. Volleyball- We are so thankful for all the support from booster. Volleyball is in full swing with preseason and district starting matches next week. We have been using the booster funds for meals for our players, we had a successful concession stand at our camp, we used funds to purchase a new uniform jersey and some much-needed equipment. We also used funds to pay for a VRBO for the players and coaches to stay in over Labor Day weekend for the volleypalooza tournament. FMBC is impacting our sport by helping us to gain community support at Meet the Mustangs. We had a great time at Meet the Mustangs and I know the players really enjoyed interacting with lots of the young kids that were there for the event.

f. General Booster Overage/Payout

- iii. Discussion: Concerns raised about distribution fairness (e.g., cheer not included). Reps reminded that coaches must communicate needs directly to Jordan.
- iv. Motion to approve allocation as a gift to athletics.
- v. **Vote:** 26 in favor, 1 opposed (32 members present)

g. Concessions Overage/Payout

- i. Proposal: Allocate \$8,000 from concessions coverage to cover weight room fees.
- ii. Players/sports will not be charged fees this year; funds will go directly to Strength & Conditioning coach.
- iii. Vote: 32 in favor, 0 opposed
